

Dear QCU members;

New Federal Government legislation affecting all Canadian Finanical Institutions took effect June 23, 2008 with the enactment

of the Proceeds of Crime (Money Laundering) and Terrorist Financing Act and Regulations (Canada), commonly called PCMLTFA. Quadra Credit Union, along with all Credit Unions and Banks, is required to comply with the provisions of the Act.

The Act requires us to collect certain personal information in "transacting" with a member; some of this information has been routinely collected and recorded in the past, but in many instances new questions will be asked of you when making some transactions. An example of this is that you will now be asked the "Intended Use" for the account you are opening, or when making an investment.

We feel it is important for members to understand that we are not being nosy, nor are we collecting data for any use by QCU itself. This information is required, by federal law, to be recorded and retained, and failure of the institution and/or an employee to do so can result in significant criminal penalties and fines. We trust members will appreciate we must comply with the law.

Members are encouraged to contact the Financial Transactions and Reports Ananlysis Centre of Canada (FINTRAC) with any questions or concerns they may have. They can be reached at 1-866-346-8722 or www.fintrac.gc.ca.



BC's Oceans: Time to Act

Colin Campbell, PhD., an ocean scientist with world-wide experience and an advisor to the Sierra Club of BC, will be giving an illustrated presentation on the state of BC's West Coast marine ecology at the Quadra Island Community Centre on the evening of Sunday, October 26th at 7:30 pm.

Marine ecologies are crucial to the overall environmental health of our West Coast and to the economic well-being of many coastal communities, including Ouadra. All our interactions with our local ocean, from commercial fishing to the many forms of ecotourism, depend on a healthy and vital marine ecology. With our marine resources under stress on a variety of fronts — including climate change - we should know the factors contributing to this situation so we can design and encourage remedies. The present challenges facing our oceans prompt Colin to urge an "integrated management regime" that he will outline in his presentation.

Colin's international experience has convinced him that the oceans are the most neglected system in conservation efforts around the world. He will offer a frank and realistic assessment of our marine ecology with practical things we can do to assure its future health.

The informative and thoughtprovoking evening, sponsored by Sierra Quadra, will allow time for a question-and-answer dialogue on this critically important environmental subject. www.discoveryislander.ca

Lecture - History of the Comox Valley

On Sunday, November 2, from 1:00 pm to 3:00 p.m., the Museum at Campbell River will host a lecture by noted historian and biographer Richard Mackie on "The Resettlement of the Comox Valley, 1862-1938." Mr. Mackie has written several books on BC's history, three of which are set in the Comox Valley. His book 'Island Timber' was a Canadian bestseller and won the Lieutenant-Governor's Prize. He is now completing a sequel to Island Timber, entitled 'Mountain Timber', which will be published in the spring of 2009. His next project is a biography of the Comox environmentalist Melda Buchanan (1924-2004).

During his illustrated slide show, Richard Somerset Mackie will trace the history of the Comox Valley from the start of British colonial settlement in 1862 to the devastating "Great Fire" of 1938. In these years, reserves were established to house the First Nations survivors of the smallpox epidemic of 1862 and the traditional territory of the Comox and Pentlatch people was made available for colonial use. Mackie will trace the arrival and settlement patterns of the colonists, the main industries of farming, mining, and logging, as well the origins of the the main towns in the Comox Valley: Comox, Courtenay, Union (Cumberland), and Merville.

Motus O Comes to Quadra

It is strange to think how a gymnast, a sheep shearer and a figure skater could have their paths meet and eventually become Co-Artistic Directors of a dance theatre company in Canada. Yet, as it turns out, that diversity has become the essence of MOTUS O, a dance company whose name means "way of movement". If you like street theatre, enjoy a romantic movie that dances around the edges of erotism, and either are looking for or have found love, Motus O's Variations on Love is for you.

In his review in the Kitchener-Waterloo Record, Stephen Preece writes, "Within the simple theme of love, the program is rich in its variation. Presented in 13 separate segments (ranging from 30 seconds to 10 minutes) a spectrum of relationships is explored. From goofy boys ogling women on a beach, to the tingling excitement of new romance, to the love lost in the death of a nephew, a series of poignant sketches express some of our deepest human needs and emotions. A strength of the performance is the group's unabashed approach to humour: ranging from all-out slapstick to more subtle devices, some kind of lightening comedic turn is never far out of reach".

The eight dancers use the skills of their varied backgrounds – from mime to figure skating, theatre to acrobatics – to explore themes of smoldering sensuality, relationship dependency, raw jealousy, seduction, and vanity. Various dancer combinations contribute to the variety, including solos and duos up to the full ensemble, each dancer bringing a unique body type and style to the performance. The company also engages a full range of props, multimedia, lighting, sound, and costumes to express its art.

Physical inventiveness, lightning action, grace, and raw energy are all trademarks of their evolving style. Toronto's Globe and Mail reports, "MOTUS O was the star turn of the night. An innovative and high energy troupe performing works that were imaginative and physically risky." Debbie Slade, Managing Director for the St Catherine's Ontario Centre for the Arts, states: "A dynamic and innovative company. Their repertoire is fresh, exciting and accessible and their energy is amazing." And in Kitchener, "MOTUS O's performance of "Variations in Love" brought the capacity audience to its feet."

Since their formation in 1990, MOTUS O has created ten full-length productions for both family and adult audiences. Disaster Exercise on Quadra Island.

Quadra Island Emergency program, along with local Fire, Police and Ambulance will be conducting an EXERCISE of the Quadra Emergency Plan on Saturday November 01/08. The main purpose of this exercise is to practice the skills that most of the volunteers in the Quadra Emergency Program have been studying during the past 12 - 18 months.

The province of BC has mandated that all communities prepare to handle the local effects of a disaster like an earthquake, a large forest fire, or major flooding. It is felt that many communities like ours will be " on their own" for up to a week. To address this, our Regional District established the Northern Communities Emergency Program, to assist in developing plans in the communities north of Comox/ Courtenay. Quadra's Emergency Program was organized by a group of 4 volunteers in Feb of 2007. Supported by Reg. District, with direction from PEP and many hundreds of volunteer hours, it has grown steadily since then to approximately 80 persons today.

Through attendance at courses offered by the Justice Institute, Can. Red Cross and Salvation Army, volunteers have gained skills in setting up and running a reception centre to register evacuees, refer them for assistance with shelter, food, clothing and transportation for 72 hours, and support family reunification. Volunteers at RCs also provide drinks, snacks, first aid, emotional support, child and pet care where needed for the evacuees.

On November 01, our Reception Center will be the Community Centre on West Rd.

As part of the exercise, an Emergency Operations Centre (EOC) will be established at Fire Hall # 1 in Cove, to coordinate the local response to the disaster by Fire, Police, Ambulance and Regional District of Strathcona. The emergency services will ID areas of damage, homes to be evacuated, and local needs. The committee at the EOC based on information communicated from the "scene" will order set up of Reception Centre, assessment of evacuees, and arrange their transportation to and from Reception Centre and coordinate needed resources from on and off island.

During the exercise we will be using our local communication VHF radios, some Family Service Radios and Cell Phones. We will be identifying at intervals that this is a PRACTICE not a real disaster, but public awareness of the event will assist with decreasing possibility of misinformation.

The set up of Reception Centre will begin before 1000 hrs (10 AM) and evacuees will arrive at the RC after 1300 hrs (1 PM) The exercise will be completed about 1500 hrs (3 PM)

Purple Martins

This year purple martins were back at the Heriot Bay public wharf by the middle of May (beginning of May in Campbell River). At least two of the boxes on the pilings seemed to be occupied in June, but unfortunately the lowest box was hit by a boat at high tide on July 1st, fell off and was lost.

Ed Silkens came over from Campbell River to help Richard Calver and me band the babies on August 20th - there were 4 young in Box 2, one was dead, probably from starvation, one escaped - they were ready to fly - so we banded two. We found a nest and 3 eggs in Box 3 but by the end of the month it appeared it had been abandoned.

Although the nesting success wasn't great here, it was poor all the way down the coast as far as Washington State, probably due to the cold wet spring and lack of insects. Still, we've got an established colony now and we'll almost certainly hear their distinctive warble again next May.

Save The Waves Local Tidal Rapids Need Protection

There are new applications for tidal power production around most of Quadra Island. These applications are part of a recent gold rush of private claims staked for potentially profitable energy sites all over BC. Labeled "green," some may be benign, but most come with environmental and social consequences. Permits can be issued with minimal public notice, scant information, and no public discussion regarding environmental impacts and existing community use. Permit approvals offer developers economic momentum that can overshadow community concerns...

As citizens we are supposed to take care of our local environment, and that is a reasonable responsibility -- we know about the area, we care about the area, and we live with the outcomes -- so being NIMBY's can be part of our duty. Sometimes we need to say "Not Here!" or "Not That Way!"

Okisollo Wave and Surge Narrows, both on the north shore of Quadra Island, have been applied for as places to site tidal power generators. This means harnessing the energy that creates the waves, and building industrial infrastructure to collect and transport the power. This conflicts with existing use. Okisollo and Surge Narrows are part of an already-strong local economy, based on wild natural features of the land and ocean.

Application # 1413161 is on the boundary of the Surge Narrows Marine Park, recently designated to protect the area's high concentration of marine life. There are no major studies about power turbines and aquatic environments, but we can assume impacts would be significant, including loss of tidal current (food supply), disturbance to fish nurseries and other marine life, toxic antifouling



agents, mechanical/industrial disruptions, electromagnetic fields, transmission lines including loss of trees and forestland, danger to migratory birds flyway... to name a few. This is too much risk to a marine park! Buildings, noise and powerlines associated with a tidal power facility would also mar the natural beauty of the remote Quadra shoreline and impact Quadra's newest (and very popular) Surge Narrows Trail.

Surge Narrows is also a well-used kayaking path and play area. Summer 2008 saw more than 1500 people kayaking in Surge Narrows, Okisollo and Octopus Islands. As a navigation channel used by large number of boaters, it is one of few access routes to the very popular Octopus Islands Marine Park. Any industrial obstruction would present a hazard to navigation and significant danger to paddlers.

Okisollo Channel generates major economic benefits for our community. This is a valuable tourism destination used by dozens of local companies. Some island businesses depend on the Okisollo and Surge Narrows tidal rapids; and BC colleges, universities, and private schools use these rapids for outdoor leadership and kayak skills training. The area has received highest praise from from two world-freestyle champions and many professional paddlers. and gained international recognition and a large audience of kayakers thanks to magazine articles and dvd's featuring the area's natural beauty and dramatic tidal features - especially the amazing Okisollo Wave at Cooper Point (application # 1413121 Okisollo) This is a unique place, like nowhere else in the world!

Orca Power, the applicant, is a new company, recently purchased by by Creation Casinos, Ltd. They are a speculative venture capital company with casino operations in Lithuania, and no previous investments in power production. http://www.creationcasinos.com/news.html

If these applications are approved it might be difficult to stop industrial developments in the Okisollo Channel. If you believe this area should remain wild, please send just a quick email to express your concerns!

Area C Regional Director's Report

would like to start this report by thanking all of you, my constituents, for continuing to allow me the honour of representing you as your Regional Director for the next three years. I feel privileged to live in this community and care deeply about the future of our area and the people who live here. I commit to you that I will do my very best to continue to represent you in an effective manner and will deal with your issues as promptly as possible at all levels of government. I look forward to working with you and to your involvement in initiatives that come up in the coming months and years. I will remain accessible, as always, at the contact information at the end of this report.

Some congratulatory comments

I would first of all like to congratulate our other locally elected representative, Helen Moats. Helen was elected by acclamation to the School District #72 position for Quadra and the outer islands. She has done a great job representing our views to the School Board and has been wonderful for me to work with on various issues. I look forward to our future collaboration.

The new Strathcona Regional District

We are now having our committee meetings at our new office in Campbell River, located at 301 - 990 Cedar Street. We have a receptionist, a Parks Planning technician and our Interim Chief Administrative Officer located in this office. The office also houses our Emergency Program Coordinator and his assistant, for the Strathcona Emergency Program (formerly the Northern Communities Emergency Program). Our Board meetings are still held at the Maritime Heritage Centre, due to the size of the room that we require for the entire Board. As soon as we can, we hope to be moving a partition wall in our new office to accommodate the entire Board and then all of our meetings will be held there.

We were notified by the Minister of Community Development that our bid to have the previous Minister's misguided decision to amalgamate Area G and Area H reversed, had been denied. So, the two areas are now one with only one director. This reduces our rural representation at the Board to four instead of five directors. The area letters for each area have been changed due to this. the new amalgamated area is Area A, Cortes Island is Area B, we (Discovery Islands - Mainland Inlets) are Area C (no longer Area J), and Oyster Bay - Buttle Lake is still Area D.

Area C (formerly Area J), now represents 48.6% of the entire SRD land base of 2,187,022 hectares for a total of 1,064,167 hectares.

It will be interesting to see what our new Board of Directors looks like after the elections on November 15th. Only a few of us were acclaimed and will return to the Board table. The others will depend on who gets elected and who gets appointed from the municipal councils. Should be interesting! I will work with everyone at the table to fulfil the needs of Area C.

Village project

I am told by the SRD that the request for proposals closes on October 31st and a consultant will then be chosen. The discussions with the community will take place regarding the "village concept" for the Cove from the beginning of January until the end of March. I will have more details after the close of the proposal process.

Meeting with our Minister

I will be meeting with our Minister, Blair Leckstrom, at 4:30 on Tuesday, October 21st, in Campbell River to discuss issues of concern to our Board. I will be bringing our applications for grants regarding the Q. Cove and the Heriot Bay sewer issues to his personal attention along with the new funding that has been announced regarding "Connecting Communities". I have requested that the SRD apply for \$50,000.00 to extend our high-speed internet services to areas that are not currently connected. I am hoping that his support of the above items will help them get approved.

Parks grant

Our Manager of Parks has applied for funding from the Community Tourism Fund to replace the aging sign that is at the entry to Blenkin Memorial Park. This will be a nice addition to our wonderful Community Centre. Another grant will also be forwarded on behalf of the Quadra Island Chamber of Commerce, from the same funding source.

Plutonic Power consultations

An issue that is front and center in our area, is the proliferation of "run-of-the-river" power projects and the hundreds and hundreds of kilometers of power transmission lines. There are more than 800 applications for projects in BC, many of them in the Toba Inlet and Bute Inlet areas. These are areas that are still "wild" and are home to many critters other than humans. These areas are also the base for many of the eco-tourism / tourism businesses that have established throughout Area C. Most of the big projects are applied for by a company known as Plutonic Power. We all want to see more renewable "green energy" come onto the market. But that is not what we are talking about here. We are talking about mega-corporations establishing mega projects, diverting rivers and streams and clearing swaths 240 feet wide to put up transmission lines. How this is "green" is beyond me.

The BC and Canadian Environmental Assessment has begun and will be reaching the public comment stage soon. When it does, I hope that you will educate yourselves on these projects and the detrimental impacts to our environment and our socio-economic situation and that you will participate, in person, in writing and in any other way that you can. There will be ads in the media and I have requested a meeting on Quadra Island They were reluctant to do that, thinking that Campbell River was good enough, until I explained where Quadra was (they didn't know), and how difficult it would be for islanders and outer islanders to attend a CR venue. We will see if they take my request seriously.

Regional Zero Waste Strategy

I would like to fill you in on what the SRD and the CVRD (Comox Valley) have been doing in regards to reducing waste. I asked Leigh Carter, our General Manager of Corporate Communications to put this together for me after some questions from constituents.

• We have completed the conceptual design for an organics composting facility which has the potential to divert over 30% of household waste from our landfills. The board has recently approved application to the province for proceeding with preliminary design of this facility.

• The addition of curbside recycling in Campbell River and the move to blue boxes in the CV has increased the diversion in 2008 of recyclable materials and the RD is working in partnership to increase education on diverting these materials.

• The Comox Valley Regional District manages over 84,000 tonnes of solid waste each year within the district boundaries. This waste, which includes a mix of household, business, hazardous and industrial wastes, is collected, transferred, managed, and landfilled by the CVRD.

• Our facilities include two regional Waste Management Centres that serve the Comox Valley and Campbell River, as well as a range of transfer stations and smaller waste handling and recycling facilities for Tahsis, Gold River, Zeballos, Kyoquot and the islands of Denman, Hornby, Quadra and Cortes.

• An important part of solid waste management is the act of diverting waste, or working to reduce the amount of waste that needs to be dealt with. When items can be reused or recycled this means they are diverted from the waste stream, which prolongs the life of our landfills.

• The CVRD oversees an extensive multimaterial recycling program and has active re-use and re-purposing programs in place at each of our landfills. At present, 32% of solid waste generated in the district is diverted through these programs.

• We also provide a wide range of educational programs - dozens of in-classroom and public sessions each year - that encourage household waste reduction through recycling and backyard composting efforts.

I know this is a long way from "zero", but it is evidence that the RD is working hard to approach this ideal goal.

I think that is about it for this issue. Director Su Rynard delivers a beautifully crafted piece about love and what the absence of it can do to the human body. Elegantly shot with effective mood scoring and dreamlike pacing, it is a story about the limits and potential of the body's most important muscle.



The picture's frame scene is the sudden collapse of middle-aged pathologist, Hope. From this point, the film lays the details of Hope's unusual past against her present day work. We meet the war veteran who rescued and raised her after she was abandoned in infancy. We witness his participation, as blood donor, in the historically significant open-heart surgery in 1955. Hope's tender memories of early childhood recall an attentive father-figure, a stark Toronto and a Scottish caregiver named Florrie.

Meanwhile, in her adult workaday life, Hope becomes the vicarious participant in the turbulent love affair of her co-workers and is drawn further into speculations of the mysteries of the human heart. Hope binds these memories and musings to her own heart as an adult, but the science never quite reconciles with the personal folklore she has woven.

Hope makes the fateful decision to uncover more details about her own early life, including the heart surgery she had at eight months of age. Through beautifully re-created operation scenes interspersed throughout the story, viewers gradually come to wonder if her blood donor was really as she remembers him.

There are many points of departure on Hope's enigmatic journey to reconciliation of what she believes with the truth she discovers. Director Rynard's artistry delivers this metaphor for love and emotion, as contemplated under the microscope of science, straight to the heart.

ccording to Wikipedia, BC Ferries (BCF) was established by the Social Credit government of W.A.C. (fondly remembered as Wacky) Bennett "in order to provide a marine extension of the provincial highway system. That system was improved and expanded through the construction of new highways and bridges, and paving of existing highways and provincial roads". Growing up during the 60's and 70's I distinctly remember the ferries as being regarded as a part of the highways system, whether you were riding a distinctive big ferry from Tsawwassen to the Island or a puddle jumper from Village Bay to Montague Harbour. The northern routes, including ours here on the Discovery Islands, were run under the auspices of the Ministry of Highways before being folded into what is now the British Columbia Ferry Services Inc. (still BCF). A major difference between then and now is the discontent of the general populace, who, in the 70's, took great pride in being owners of the largest private ferry fleet in the world, with a safety record second to none. Today, the major reaction of regular resident ferry users (or "customers", as they would have it) towards the Corporation is primarily anger. With pretty good reason, I would say.

Now, as then, we have every reason as taxpayers and citizens to be proud of our ferry system – it a wonder of the world in efficiency and managed complexity that delivers good service in a demanding environment. It provides an essential service to a large percentage of the population, contributes uncounted dollars to the economy via tourist traffic, and furnishes good employment to a large number of coastal residents. And last year the Corporation made about \$48 million net...not a bad performance at all. Why then are so many coastal residents angry at BC Ferry Corporation? Maybe it is because we feel like we are being picked upon.

I have been a regular customer of the ferry system in one form or another since 1983, but my wife has been a full time commuter (i.e. twice a day, 5 days a week) since 1997. I honestly don't remember - nor can I locate any information related to – the average monthly cost of the ferry to our household back then. Today my wife's daily employmentnecessary commute, were she to drive every day (which she does not) would cost us approximately \$525 per month. Through alternative transportation she brings this cost down to, on average, perhaps \$200 per month. This is ferry cost alone, of course. It took about \$3,000 to fund the vehicular green alternative Norma has chosen; losing the missing comfort of a vehicle on a rainy windy day heading north of Campbell River is an intangible cost. But my point is that Norma, like many other Island residents, depends on the ferry as a mode of public transportation, which is exactly the model, I believe, Wacky had in mind back in 1959 whilst dreaming up the concept.

A common rationale for constantly raising ferry fares is that we, as users, have made a lifestyle choice to live where we live. One cannot refute the logic because, of course, we did. Or many of us did, since there are a significant number of Island residents who were born here, thus having little choice in the matter. But having agreed we do choose to live here, am I wrong to understand the Charter of Rights and Freedoms grants us that right to choose where we live? And if that indeed is the case, do we not have exactly the same rights to the provision of highway services as do residents of Anahim Lake, Beaverdell or Stewart, BC? As far as I know, residents of those towns do not pay any extra tolls, tariffs or fares to utilize their highway system, in spite of the fact the provision and maintenance thereof is subsidized in the millions of dollars by BC taxpayers very year.

Or how about the people of the Arrow Lakes region, who involuntarily lost their road access through their deep valley countryside alongside scenic Columbia River tributaries? The 1961 Columbia River Treaty and subsequent damming required the provincial government to provide ferry services in lieu thereof, which service is - to this day - provided free of charge by the government (albeit via private contractor). Those people choose to live there...why shouldn't they pay their fair share of the ever-increasing running costs of their marine highway?

A recent news clip of Premier Campbell, announcing the end of the Coquihalla tolls (complete with coverage of the next day's dramatically enacted destruction of said toll booths) was met with dismay by my wife and I. Again, we see a portion of the highway system being "fiddled with", to borrow an old ancestor's phrase. Apparently we Island dwellers have become elitist, requiring services above and beyond those envisioned by the ferry systems creators and therefore unworthy of equal (or at least equitable) treatment as beneficiaries of publicly funded transportation. When do we stop paying our "toll", being the amount over and above a reasonable fee to subsidize our marine highway? When will the "fuel subsidy" that BCF seems desperate to keep collecting be entirely reversed? When will we ferry riders get a break?

It is important to note that when our provincial government funds travelling tourism roadshows - costing millions of tax dollars - all around the world promoting the glories of BC, our ferries and the magnificent destinations they serve are major "hooks" in the message. Our coast and the communities it embraces are a large part of what British Columbia is. We are an integral part of the fabric of British Columbia, and it is patently unfair that we are seeing our "transit" fares rise at double digit annual rates while our asphalt dependant neighbours only see higher costs in their fuel taxes. Which taxes, by the way, we pay as well.

The time has come to look to the past for guidance, which is so often the case. Transportation in all of its forms used to fall under the auspices of a provincial Ministry of Transportation – kind of makes sense, don't you think? If we are to accept the Charter rights as a given, then it is incumbent upon our government to find an equitable manner of distributing the costs of providing transportation services to our residents and our visitors, no matter what the destination if it is already a part of our provincial highway system.

By the way, in the course of researching I was unable to find any information whatsoever as to the cost of provision of our inland ferries system, most of which are cost-free to the user. I spent many fruitless hours searching government records but apparently the information is not posted for public consumption. Might I respectfully suggest that our MLA, being a significant user of the ferry system and representing a constituency largely the same, take it upon herself to determine how much it costs us to subsidize our inland ferry riding residents choice of a home? I suspect that the number will be a significant one, and if brought to the public eye might stimulate a healthy debate about appropriately distributing the cost of living in paradise, a distinction which every British Columbian shares no matter where they choose to live.

For Whom the Fare Booth Tolls

month ago Premier Gordon Campbell announced that tolls would be removed immediately on the Coquihalla Highway, eliminating \$57 million in annual provincial revenue and putting "literally hundreds of dollars in the pockets of British Columbians who regularly use the highway."

The Ministry of Transportation said 2.7 million passenger vehicles and 700,000 trucks travelled the Coquihalla last year. Trucks paid more than half the total toll revenue, Campbell said. "It will mean thousands of dollars in annual savings for truckers."

Wouldn't it be nice if he would develop a similar appreciation for the plight of British Columbians who depend on BC Ferries as an integral part of the provincial highway system on the coast?

BCF's annual report says its ferries transported 21.7 million passengers and 8.5 million vehicles in the year ending March 31. The cost of ferry travel obviously affects a significantly more people than the number who use the Coquihalla where tolls could be justified by the fact that there were alternate, though slower, highways people could travel for free.

The BC Ferry Commissioner has just produced charts indicating that users of the ferries between Vancouver Island and the mainland have been paying 110% of the annual cost of operating those routes since 2003. However, most smaller ferries are far from self-supporting, and the extra income from the big ships cannot be used to cover their costs under Campbell's Coastal Ferry Act. It divided BCF's routes into four groups and outlawed cross-subsidization. The "surplus" is being used to make BC Ferries look profitable to its private financiers.

The Commissioner says that since 2003 the percentage of user pay has increased from 71% to 93% on the Horseshoe Bay-Langdale route and from 35% to 43% in the 18-member minor route group, which includes Quadra and Cortes.

"In the Northern route group," the Commissioner said, "increased provincial funding on amortization and the cost of capital on new ship and terminal investments, paid via higher transportation fees, plus provincial contributions towards extraordinary fuel costs, meant that user pay declined from 41 % to 31 %."

The transportation fee is the annual amount *www.discoveryislander.ca*

the province gives BC Ferries to support service where fares do not cover costs. BCF has been allocated \$71.5 million annually from 2003 through 2012 for the minor routes. As costs increase, the Commissioner has had to follow the government's rules and allow BCF to raise fares and impose fuel surcharges when marine diesel exceeds a set price.

Keep On Truckin'?

These fare hikes have not only taken hundred of dollars a year out of ferry users' pockets, they have also resulted in substantial increases in the cost of goods and services in ferry-reliant communities. Among those 8.5 million vehicles on BCF's decks last year were an unspecified but obviously large number of commercial trucks which supply island communities with food and manufactured goods. Trucks also haul the produce of farming, aquaculture, forestry and island manufacturing to the lower mainland.

Commercial fares are a major factor in the cost of living and doing business across the water. Since 2003, freight costs have increased as much or more than fares for passengers and private vehicles.

Michael Gibbons, who operates Cortes Transport, says his 42-foot semi, "Pearl," made 102 roundtrips from Cortes to Vancouver in 2003 at an average cost of \$350. After the August 1 fuel surcharges, the same trip cost \$741. "Pearl" hauls oysters and other shellfish to processors on Vancouver Island and in the Lower Mainland. Michael has to pass increased fuel and ferry costs through to his customers.

"We've lost a lot of shellfish business in the last three years," Michael said in an email. "The main reason is growers cannot recover the increased cost of doing business. We've cut one trip per week to Vancouver. The only thing saving us is the huge increase in freight we are hauling to Cortes Island."

And that is happening largely because it is now cheaper for Cortesians to use services like Cortes Transport and the Cortes Connection than to make the trips ourselves.

On the other side of the equation, BC Ferries notes in its 2008 annual report that it is "witnessing increased competition in the commercial sector where three companies, including ourselves, are vying for different segments of the freight transport business between Vancouver Island and the Lower Mainland.

"To maintain and potentially increase our market share," BCF says, "we plan on improving operational efficiency and customer service on our three major routes by increasing capacity for both commercial and passenger vehicle traffic with the assignment of one Super C-class vessel to each route."

But it's obvious that cost is the driver for freight companies, and the government's insistence that the major routes pay their own way is creating a situation where private companies can compete. This, of course, fits right in with the Liberals' love of privatization, except for the fact that BC Ferries has just spent hundred of millions of dollars on the three new Super C ferries, and taxpayers ultimately will be on the hook for that debt if BC Ferries can't pay for them out of the fare box.

Here Come The Cuts

Right after the Thanksgiving weekend, BC Ferries started cutting sailings on both the major routes and between Horseshoe Bay and Langdale because of a 12 % drop in traffic in September following a decline in July and an average August. Early Sunday morning sailings were the first to go, and part of the plan involves parking the new Super C's and using the smaller, older C Class ships.

"When you see traffic drop off," BCF spokesman Mark Stefanson said, "you don't need a larger ferry." The Campbell River Mirror responded to this news with an editorial titled "Another Ferry Fiasco Brewing."

While it's no doubt true, as BCF President & CEO David Hahn argues, that high gas prices and the early stages of the economic meltdown had an effect on BCF's traffic, there's also little doubt that high ferry fares are keeping people closer to home.

It is notable that no fare reductions were mentioned in connection with cutting back on service, and FAC chairs for the Southern and Northern Sunshine Coast were quick to protest the fact that there was no consultation with them about dropping sailings between Horseshoe Bay and Langdale.

Now gas prices and BCF's fuel costs have both come down, and last week the BC Ferry Commissioner "allowed" BC Ferries to cut the August 1 fuel surcharges by 50%, effective Tuesday, November 4.

For a car and driver, that will reduce the cost of a Campbell River-Quadra roundtrip by \$1.50 and of a Cortes town trip by \$3.55

whether you pay cash or use an Experience Card. It will also cut in half the commercial vehicle surcharge which is 37 cents per foot from Campbell River to Quadra and 55 cents per foot for trucks from Quadra to Cortes.

While the reduction is definitely in order, it is hardly reassuring when one looks at the big picture.

Meeting the Minister

The FAC Chairs recently submitted a discussion paper to the Minister of Transportation and Infrastructure Kevin Falcon titled "Towards A Minor Route Strategy for Coastal Ferry Service," and three of us went to Victoria yesterday (October 23) to meet with him. I'll report on that meeting in the next issue.

The discussion paper offers the FACC perspective on a wide variety of topics and points out that the Coastal Ferry Act was introduced "to provide a financially stable transportation system intended to ensure modest and predictable fare increases, to promote enhanced economic development and to support tourism while protecting taxpayers from financial risk and debt."

The paper acknowledges that the "new business model has enabled more efficient service delivery and effective capital planning," but it notes that "the following were not anticipated: increasing operational costs, especially those related to fuel; high capital costs to remedy the lack of previous investment in infrastructure; and resulting fare increases at a level that undermines the capacity of the system to promote economic development and to support tourism."

It suggests a strategy that could include "promoting increased traffic through tourism marketing initiatives, pursuing cost reductions through innovations and service adjustments, and mitigating fare shock through transportation fee adjustments."

It's important locally to remember that these ideas are the synthesis of the thinking of people who represent 22 ferry routes on the coast. Web masters willing, the entire document will be posted on thegunboot.com and cortesisland. com in the next few days.
